ON THE APPLICATION of the plaintiff, without a hearing and on reading the materials filed by Jen Winstanley for the plaintiff;


THIS COURT ORDERS that:

1. For the purposes of this Order, the definitions set out in the Third Distribution Protocol apply and are incorporated into this Order.
2. The Third Distribution Protocol is hereby approved and shall be implemented in accordance with its terms.
3. The Third Distribution Protocol shall govern the administration of the Settlement Agreement entered into with Sharp Corporation (the "Settling Defendant"), dated September 23, 2020.
4. RicePoint is appointed as Claims Administrator.
5. The settlement amount paid in accordance with the Settlement Agreement shall be distributed by the Claims Administrator in accordance with the Third Distribution Protocol.
6. All information received from Settlement Class Members collected, used and retained by the Claims Administrator for the purpose of administering the Settlement Agreement, including evaluating the Settlement Class Member's eligibility status under the Settlement Agreement and is protected under the *Personal Information Protection and Electronic Documents Act*, SC 2000 c 5. The information provided by the Settlement Class Members is strictly private and confidential and will not be disclosed without the express written consent of the relevant Settlement Class Member, except in accordance with the Settlement Agreement, orders of this Court and/or the Third Distribution Protocol.

7. This Order is contingent upon parallel orders being made by the Ontario Court and the Quebec Court, and the terms of this Order shall not be effective unless and until such orders are made by the Ontario Court and the Quebec Court.




